



A MESSAGE FROM KIMBERLY-CLARK WOODLANDS CONCERNING PUBLIC USE OF ITS ACCESS ROADS.

K-C will continue to offer the free use of its roads to the public except at times, and in places, where the safety of the forests or of our employees is endangered.

The protection of employees from accidents, and forests from fire, is an important part of the company's responsibility as an employer of woods labour. With this responsibility in mind, the following policy concerning the Camp 12 access road has been placed in effect.

IN FIRE SEASON

During periods of high or extreme fire hazard, gates "A" & "B" will be closed. In case of emergency, keys may be obtained from the Mill Manager or his representative, or from the Cp. 12 Foreman.

IN HUNTING SEASON

If the river drive crew is working on the stretch between Upper Aguasabon Lake and Cp. 12, gates "D" & "E" will be closed.

If the river drive crew is working on the stretch between Cp. 12 and the Mill, gate "A" will be closed. If the river drive crew is not working between Sat. noon and Mon. morning, no gates will be closed during this period.

Since these controls are necessary, & have not been placed in effect as a challenge to individuals, it is requested that:-

1. The gates are respected.
2. Careless use of firearms is avoided.
3. Fire prevention regulations are adhered to.
4. Company property such as camps, boats, bridges, machines, signs, etc. are not damaged maliciously.
5. Parked vehicles do not block the road and prevent the passage of others.
6. Safe speeds only are maintained on the narrow road.
7. The safety of the men working on the drive and all others be considered at all times.
8. Persons using the road do so at their own risk.
9. The usual D.ofL.&F. Travel Permit & K-C Road Permit will continue to be required.
