### MUNICIPAL NOMINATIONS

Notice is hereby given that a meeting of the electors will be held in the Municipal Office on Monday, November 26th at 7:30 o'clock until 8:30 o'clock in the afternoon for the purpose of nominating persons for the offices of Reeve and four Councillors for the year 1963.

Every nomination shall be in writing and state the name, residence and occupation of the candidate, and the residence and occupation of the proposer and seconder and shall be signed by the proposer and seconder, both of whom shall be Municipal electors and present, and shall be filed with the Returning Officer within one hour from the opening of the nominating meeting.

Where a proposed candidate is not present his nomination paper is not valid unless there is evidence, satisfactory to the Returning Officer, that he consents to be so nominated.

Candidates are required to file with the Clerk a certificate of the Treasurer that there were, at the time of the opening of the nomination meeting, no unpaid taxes for any preceding year against the land in respect of which he is qualifying, and no unpaid taxes against him in respect of an assessment for business, or a statutory declaration made to the same effect.

### MUNICIPAL ELECTIONS

Elections, if necessary, to fill any of the above positions for the year 1963, will take place on Monday, December 3rd, 1962, between the hours of 9 o'clock A.M. and 7 o'clock P.M. in the polling places designated.

### NOTICE

By-Law No.133, a by-law for disqualifying from voting, electors who are in arrears for taxes, provides as follows:-

"No person whose name appears on the defaulter's list, provided for by Section 104 of the Municipal Act, shall be entitled to vote at a Municipal Election in respect of real property unless, at the time of tendering his vote, he produces and leaves with the Deputy Returning Officer, a certificate from the Treasurer or the Collector, showing that the taxes in respect of which the default was made have since been paid."
