by a citizen and the clerk was instructed to send the desired information; Linkon Co. wrote requesting a vote on the liquor question, also regarding the assessment on the Hotel lot and business tax reduction on the Mayfair Theatre and the Mental Health Association requesting consideration when the 1963 budget is prepared.

A discussion was held on the matter of installing gas tanks for supplying the Town trucks but no decision was reached.
