COUNCIL QUOTES - MEETING TO BE IN EVENINGS

Reeve J.P. Heenan chaired the regular meeting of Council Wednesday afternoon in Council Chambers. A full complement of Councillors completed the business at hand: Councillors Fraser, Valiquette, Wellings and Adamo, Secretary Strutt and Clerk Hanley.

Changes in meeting dates for Council were established as the second and fourth Monday of each month at 7 o'clock, unless notification was served otherwise. The Reeve also asked for a special meeting of Council to dis-

cuss a requested wage adjustment.

A report on dog control in neighboring town was brought in by Councillor Wellings. Councillor Valiquette remarked on the numerous complaints swamping Constable Billings and reiterated his suggestion that licenses be raised to \$10 and \$20. Councillor Adamo objected, feeling the stiffer penalty belonged to those flaunting the law. He saw no reason why dogs running loose should not he picked up by means of net or tranquilizer gun and, notification failing to bring about an immediate release into the custody of the owner, the dog be disposed of. Reeve Heenan recognized the situation as a continuing nuisance and promised to call upon the dog catcher to make a more sincere effort. The Secretary informed Council dog tags were up for renewal March 1 at \$2 and \$4. This could be changed by By-Law as could also the fine levied when a dog was Sec. Council received correspondence from attorneys for the Circle Route Service Station requesting a copy of the Town's By-Law pertaining to Garages and Service Stations, and additional information. It was their contention refusal of a garage license was discriminatory and they slought comments on the establishment of application for a garage license for their client. Council replied in full, stating their client had been aware of the Town's existing By-Law when they established business and there was no question of discrimination. The Reeve reported being in touch with the Garage in question, who were attempting to secure the services of a mechanic. Councillor Adamo noted the complaining Service Station was not adhering to the letter of the law in their service and sales and felt they should be investigated. Reeve Heenan would see they were fully acquainted with the By-Law.

Council was informed of the admittance to Ft. William Sanatorium of a local resident. The C.W.L. were granted permission to have a Tag Day March 16th.

A complaint was received following scraping and removal of snow from streets on the inaccessibility of driveways, with a select few driveways cleared. Councillor Wellings elaborated these driveways were no doubt on the list for regular maintenance which would keep them levelled. Reeve Heenan (Continued P.9)
