WHO IS ELIGIBLE TO JOIN? The By-Laws state (and these are approved by the Supervisor of Credit Unions and the Department of Insurance): Art.1 (a) "Memb ership in the Credit Union shall be limited to, residents of Terrace Bay, persons who work in or reside in or within a fifteen (15) mile radius of the Terrace Bay Post Office."

Application for membership shall be made in writing and shall be presented to a meeting of the Board of Directors for its approval. Accepted applicants shall not become qualified members until he/she has paid an entrance fee of .25¢ and has subscribed to one or more shares. A share is \$5.00. All non-members are hereby invited to investigate membership by applying at the office on Simcoe Plaza or contacting any officers of the Terrace Bay Community Credit Union Limited.
