Motors property indicated that when foreclosure proceedings instituted by B.A.Oil Company are completed the Company will do the cleaning up.

The Township's responsibility in the matter of funeral expenses for accident victim were outlined in several communications. Mrs. V.Hopper, R.N., asked for clarification on hours and duties of school Nurse. The Committee and Medical Health Officer will meet with her to reach a definite conclusion.

Recommendations by Council for action on the recommendations handed down by a recent coroner's jury were the theme of a letter from the Chief Coro-

ner of Ontario.

The Fire Department Report for June mentioned two call-outs: that the Roxy Theatre replace their fire extinguishers and observe the "no smoking laws": recommended that Terrace Bay join the Thunder Bay Mutual Fire Aid Plan: (this was passed on to the Committee for investigation) and a report on practices.

The Police Department Report indicated a quiet month--only two thefts, one at the Community Church and one at the Roxy Theatre: a report on township and highway accidents: the usual complaints on dogs and cats: a warning to juvenile owners of skate boards that it is NOT permissible to use same on streets.

Library, Snack Bar, Hydro, Township and Recreation accounts were considered and passed for payment.

Two applications for the job of Cemetery Caretaker were received and that of J.St.Louis, who has been assisting there, was accepted.

Councillor Cavanaugh's request for action on cleaning boulevards sparked a debate on responsibility of the Roads Supt. As 'Roads Supt.' he should be aware and recommend to Council areas for improvement. Councillor Thompson, in line with a local brief which deals with providing employment for youths moved that six 16-17 year olds be hired to work under the direction of a Mill lead hand whose services will be donated by the Company, to do brushing and general clean-up jobs around town.

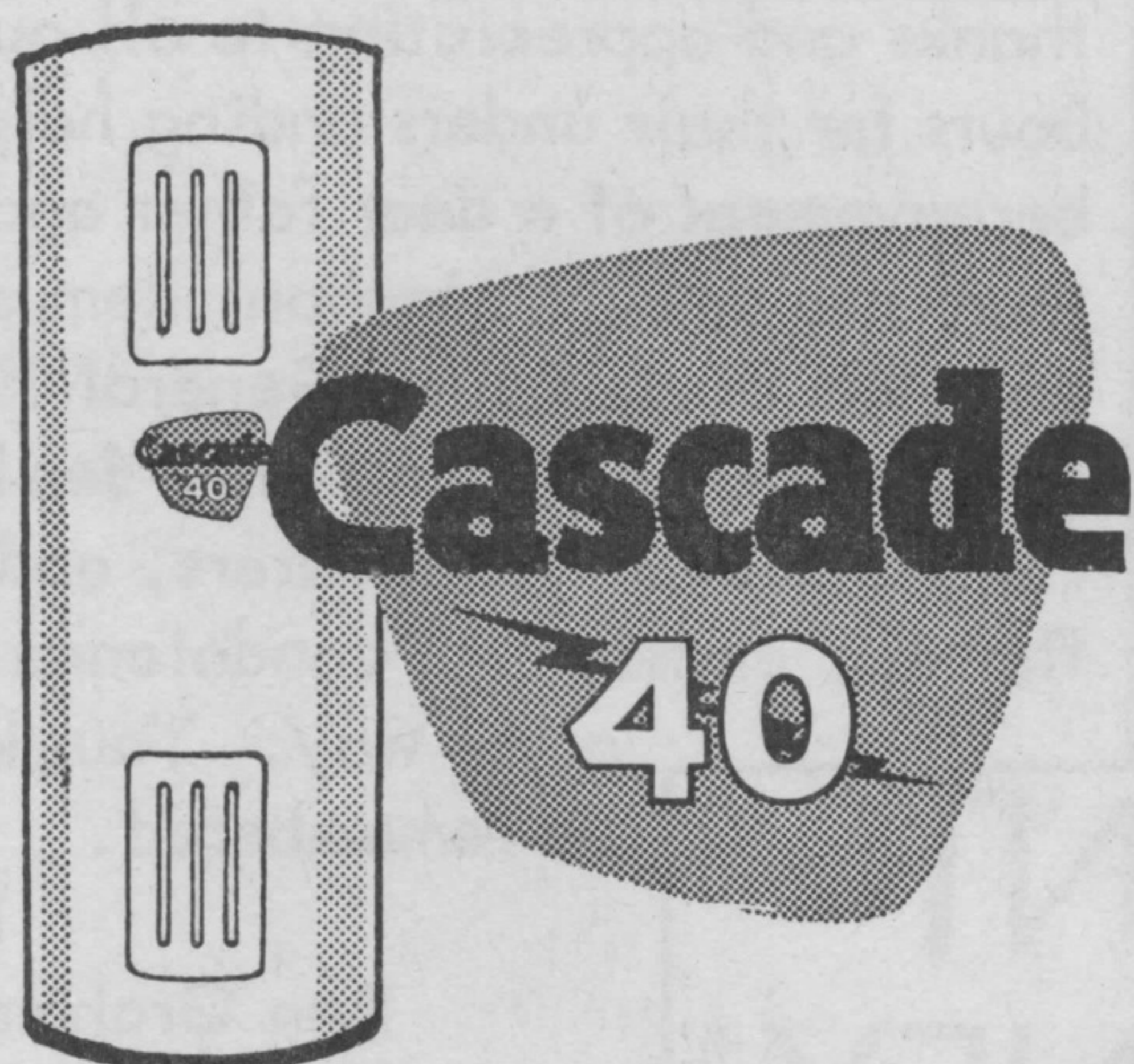
Councillor Thompson asked who approved Building Permits and all Councillors agreed that though these were nominally given by the Building Inspector and Electrical Supt., Council should be kept aware of those that are granted and for what.

Councillor Thompson also raised the question of the legal aspect of property owned by H.Lohr on Laurier Avenue which, though in a residential area, is solely a business and income property. The situation will be investigated.

Reporting for the Recreation Committee, Councillor Thompson indicated that a long-range development plan is in progress to make all facilities available for more projects and groups. A meeting with J.Reid on the Centennial Project resulted in other proposals being dropped in favour of an Adult Study Lounge in conjunction with the Recreation Centre--providing the necessary property can be acquired.

Councillor Fraser discussed the problem of cleaning up in the Shopping Plaza and said Councillor Brown had approached proprietors of the various businesses. At this point it was proposed that a By-Law (Cont'd Page 7)
