## COUNCIL QUOTES

Water charges were reviewed at the September Council meeting and rebates were allowed to Birch Motors, through the restaurant operation and, in Filane Restaurant case, the levy was changed from restaurant-store to restaurant-apartment.

Reeve Harness reported meeting with W.J.Sauriol in connection with delinquent fees for the YMCA. It was decided that the matter will be left until after the YMCA;s board meeting and, failing a satisfactory decision, the matter will be put in the hands of the town attorney.

Members are not satisfied with the Liquor Control Board's reply that, under present conditions, they cannot grant a liquor outlet to Schreiber. A letter containing explicit reasons why Schreiber feels it will benefit from an outlet here will be sent to the Board and also assistance in the issue will be sought from Hon. George Wardrope, MLA.

Councillor J.M.McGrath was appointed to meet with the fire brigade regarding the resignation of W.R.Weaver as fire chief, effective October 19.

Council agreed to meet with Nipigon council finance committee on the problem of appointing municipal assessors.

The ever-present dogs-running-at-large nuisance was again considered and efforts will be made to meet the problem by appointing an official dog catcher. The difficulty here is not financial but social, the last man holding the job resigning because of the ill-will he incurred with his own children whose sympathy was with the cul prits.

Spadoni Company wrote again concerning sewer line, in light of recent public release by Ontario Water Resources Commission concerning provincial financing of water and sewage projects.

The request of Police Chief S.W. Timmerman for holidays from October 2 - 8 was turned over to the Police Commission.

N.J.Jolicoeur was appointed council representative to the Schreiber-Terrace Bay Children's Aid Society.

The Lions Club requested better supervision be given school children at intersections on either side of the subway and Council replied steps have already been taken.

Councillors McGrath and McParland were named to meet with the CPR regarding sewer and water facilities in the proposed development of Bayview Street.

A meeting will be planned with A.R. Morpurgo, district planning advisor, to consider suitable by-laws to implement development policies.

Waterworks accounts of \$2,026.31 and general accounts of \$4,433.20 were passed for payment.
