About 95% of Canadian children attend schools built and operated by Government. These children pay no fees--the cost of their education being borne by local taxes and by provincial grants. The remaining 5% attend private schools where fees are paid or Indian and Eskimo Schools and the schools overseas attended by children of Canadian Servicemen. Attendance at all levels of education has expanded tremendously. In Lakehead University alone it is expected that enrolment will triple to 2,000 by 1970.

There was some discussion on selling Almey crabapple trees, the Centennial tree, but no decision was made.

Mrs. Whitton displayed an ancient Irish coin and mug, family heirlooms, and two small shoes, which were later used as the tea table centrepiece.
