A further request was made to Double Diamond Bowling Co. to supply a spare parts and tool kit before final payment is made on the installation.

In a letter from the Library Board, council was asked to approve the appointment of Mrs.Shirley Angus and Mr.Bob Roberts to the Board, following two resignations.

Councillors Sinotte and Desrosiers will attend the Municipal Councils of n'western Ontario convention. Councillor Sinotte and Fire Chief Ralph Cole will attend a meeting in Fort William where the main topic will be the mutual aid scheme for the district. The Recreation Director, one member of the Recreation Association and one Councillor will attend the convention of recreation associations in Fort Fr ances.

Clerk-Treasurer W.J.Hanley was directed to prepare a By-law to bring into effect two-year terms for memb ers of Council, together with the Public * School Board. Nominations are to take place on the second last Monday in Novemb er with election day on the first Monday in December. He was also appointed temporary assessor and empowered to hire a cleaner for the office building.

Three applications were considered for the position of building inspector and a decision is expected following meetings with the applicants.

The Police Department reported a quiet month – one listed missing person had been successfully located.



Accounts totalling \$102,193.48 were approved and passed. A resolution from Elmira and Thorold regarding the mounting cost to municipalities of education, was read and endorsed by Council.

The local Ski Club asked for financial assistance in setting up insurance coverage for its members. Council agreed that, like the Recreation Association, it is unable to make provision for grants to individual organizations, and therefore regretfully turned down the club's request.

The District of Thunder Hay home for the aged has requested suggestions for a name or names for the proposed homes. It was also pointed out that the first payment on the home was due - notwith standing a pending enquiry. The inquiry which will deal with the equalization of payments will be attended by Councillor Ken McLeod. At a recent Recreation Association meeting it was unanimously agreed that Council should take over the running of the Snack Bar immediately following an inventory to be taken by Mr. Heenan. A committee of Reeve Adamo and Councillor Sinotte will be responsible for the management until such time as they feel ready to lease out the concern. Councillor Bill Kurylo asked to be relieved of his position on the Recreation Committee.
