room of the Recreation Centre on Sunday afternoon. The meeting was chaired by Mr. R. Sinotte, in the absence of Mr. Cavanaugh. Recreation Director D. Courtemanche and Mr. B. Rowsome, Principal of the High School formed the panel.
