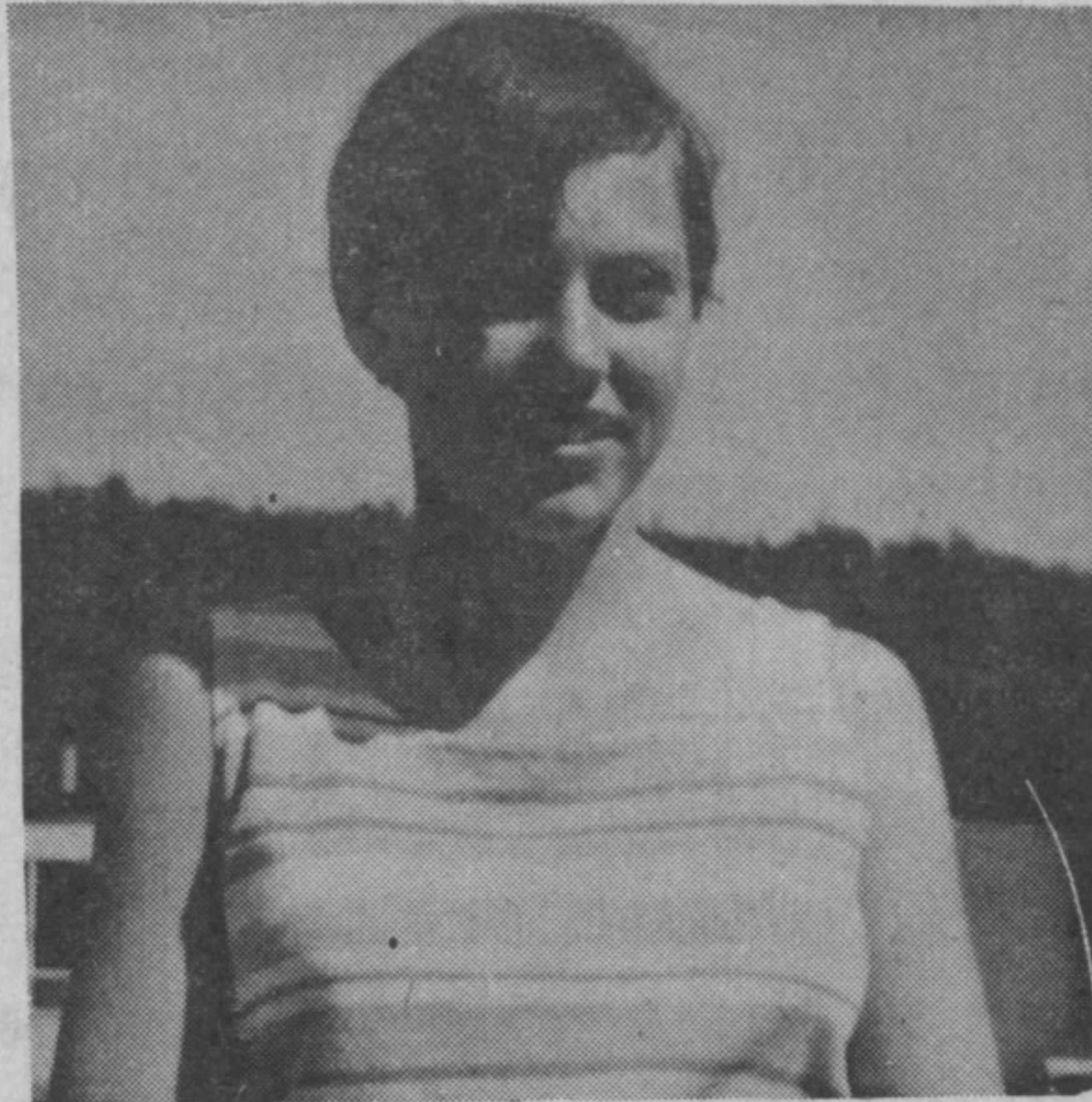
In the afternoon, a reception was held in the town hall when Mrs. Gagnon received in pink metallic sheath with lace coat, petal hat and white accessories.
