following the mill start-up. (Moberly Bay in Jackfish Harbour is 6-1/2 miles by boat east of the Pumphouse at Terrace Bay. A sketch of this system appears on Page 19 of this issue of the NEWS.

Two things should be emphasized, one is that the land containing the creek and settling lagoons is owned outright by Kimberly-Clark and is used for the sole purpose of restoring mill effluent to Lake Superior in the best possible condition. The other point is that Highway 17 did not exist when the effluent improvement system was designed - the Highway was construct-

ed much later, crossing the effluent system. The effluent system is made up of 17 miles of creek and about 115 acres of settling lagoons, the combined purpose of which is to reduce the Bio-Chemical Oxygen Demand and the suspended solid content of the effluent before it enters

Lake Superior.

It is quite fair to question the efficiency of this system as it affects the waters of Lake Superior. During 1965 a team of experts toured all pulp and paper mills in Ontario and reported on the condition of effluent at all the various mills. It is significant that these experts in their report stated "this Company (Kimberly-Clark) has surpassed the O.W.R.C. (Ontario Water Resources Commission) objectives by a large margin".

In 1967 the pulp and paper mills in Ontario were re-surveyed and at that time the report on Kimberly-Clark's mill at Terrace Bay concluded "the effluents from this mill are under excellent control".

The Ontario Water Resources Commission has also recognized the efficiency of the effluent system at the Terrace Bay Mill, and in a letter to the Mill Manager dated October 13, 1964 stated "It is recognized that the problem of waste treatment and control in the pulp and paper industry is very complex and that there are serious economic as well as technical considerations that must be kept in mind. We appreciate the interest that your Company has shown in this matter and feel that your control measures have been effective in protecting Lake Superior". The mill has no subsequent indication from the O.W.R.C. that they have in any way changed their appraisal of the effluent handling system at Terrace Bay. Constant check is made of conditions in the effluent stream by qualified personnel.

This effective control is not happenstance.
