



**DEPARTMENT OF MUNICIPAL AFFAIRS**

**ORDER MADE BY THE MINISTER UNDER THE PLANNING ACT**

I. All lands in the Improvement Districts of Beardmore, Manitowadge, Nakina, Marathon, and Red Rock, in the Territorial District of Thunder Bay, are designated as areas of subdivision control under clause b of subsection I of section 27 of the Act.

It is important to note this Order may affect the validity of any future agreement for the sale of land and the validity of a deed, mortgage or lease and it is recommended that advice be sought before entering into any such transaction.  
It should also be noted that the regulations relating to land and buildings in this Order may not be the only regulation applicable in the area covered by the Order. Prior to developing land or erecting buildings, consideration must be given to these and other regulations and procedures that may be established by the Department of Municipal Affairs, or such other departments as Highways, Health, Lands and Forests, Tourism and Information.
