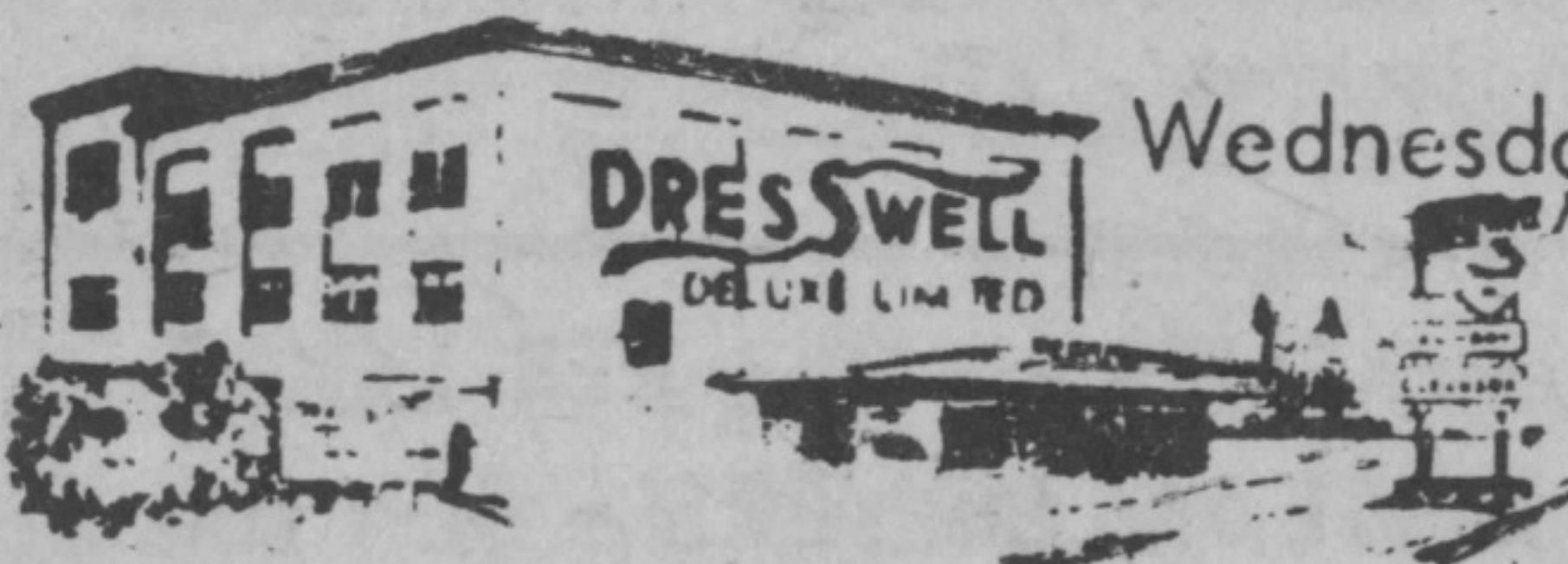
SCHREIBER DETACHMENT O.P.P. PRESS RELEASE
