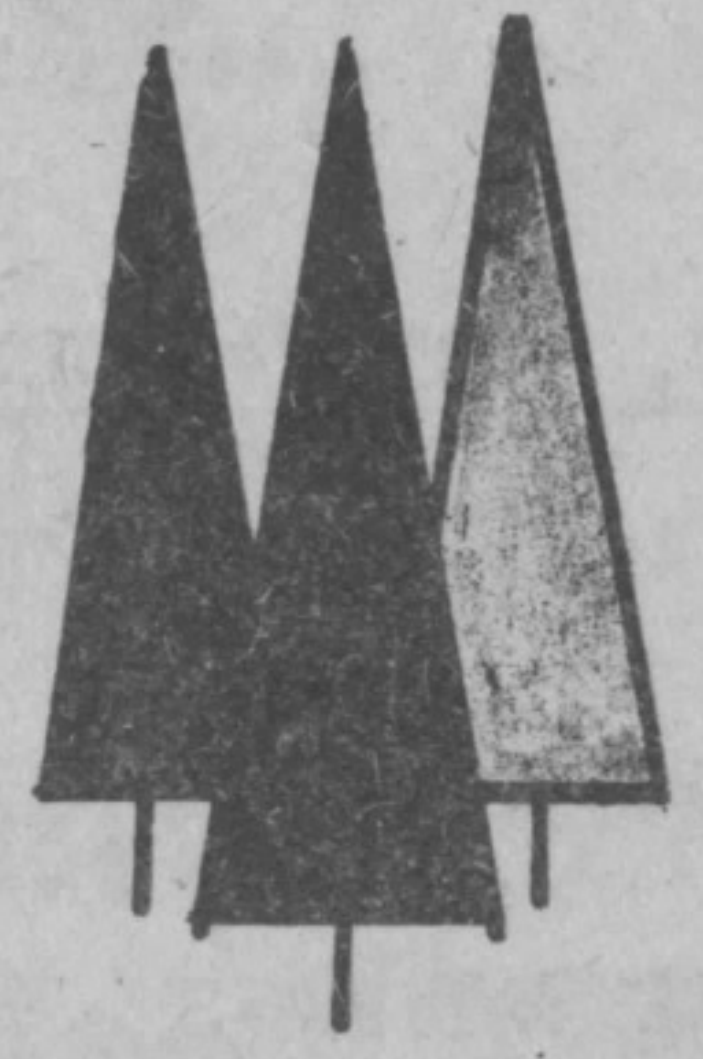

## ATTENTION HUNTERS UNDER 16 YEARS

Following are the new amendments to the Criminal Code covering Fire arms and the issuing of permits to minors -

Definition: 82 (b) C.C. - "Firearm" means any barrelled weapon from which any shot, bullet or other missile can be discharged and that is capable of causing serious bodily injury or death to the person, and includes anything that can be adapted for use as a firearm;

Seizure: 98 (a) c.c. - A peace officer who finds a person under the age of sixteen years in possession of any firearm or ammunition who is not the holder of a permit under which he may lawfully possess it, may seize such firearm or ammunition and take it before a magistrate who may, after affording the person from it was seized or the owner thereof, if known, an opportunity to be heard, declare it to be disposed of as the Attorney General directs.

**NOTE** - These permits are issued by the Ontario Provincial Police, Toronto - ONLY

## CANADA SAVINGS BONDS - 1969

The 1969 Canada Savings Bonds will go on sale October 15. All regular Kimberly Clark employees will be contacted and offered the opportunity to purchase bonds through the payroll savings plan.

The 1969 series will yield interest at an average of 8% per year when held to maturity and the compound interest feature which makes it possible to receive two times your investment in nine years.

Last year 60% of Kimberly Clark employees purchased bonds for an average individual purchase of \$467. They recognized that the payroll savings plan as a convenient way to purchase bonds.
