Report of stolen auto was investigated. Vehicle located with no apparent intent to steal evident. Other investigations included: - two Break and Enter occurrences were reported in Rossport area; presently under investigation; damage to Township property investigated and resulted in charge of Wilful Damage being laid; theft of articles from a motel room investigated, resulting in three charges of Theft under \$50.00 and two charges of False Registration under the Hotel Registration of Guests Act being laid. One report of dangerous use of firearms was investigated, resulting in two juveniles being charged; three investigations were conducted. with regard to violations under the Liquor Control Act and charges laid in all three instances; assistance was rendered to four Americans whose large house boat ran aground on the shore of Lake Superior near Rossport, the craft was saved from serious damage mainly through the efforts of several local residents who volunteered their assistance.

On the Traffic Scene: one fatal collision occurred October 6, near Pays Plat River Bridge, Highway 17, which claimed the life of Ernest James Burr, age 53, of 423 Merril Street, Port Arthur. Death occurred when the vehicle operated by the deceased went out of control and collided with a rock cut. The vehicle was totally wrecked.

Three other collisions were investigated which resulted in no injuries but approximately \$1900.00 damage. A total of eight warning were issued.

Parents are urged to impress upon their children the importance of safe bicycle operation on streets and roadways. Bicycles being used during periods of darkness must be equipped with lights as provided under the Highway Traffic Act. Strict observance of these requirements must be kept.

Total duty hours amounted to 200 with 2435 miles patrolled on Highways and Other Roads.
