LETTER TO THE EDITOR

As an insurance agent and in view of the number of clients I am serving in the area and the increasing number of accidents arising from the use of snowmobiles, I feel a responsibility to bring to the attention of the owners of motorized snow vehicles the restrictions and exclusions that are written into the insurance policies which are providing Public Liability and Property Damage.

These exclusions are written into the Statutory Conditions of the Standard Automobile Policy and are applicable to all companies insuring snowmobiles on an automobile policy form.

PROHIBITED USE BY INSURED -

1. The insured shall not drive or operate the vehicle a. while under the influence of intoxicating liquor

or drugs to such an extent as to be for the time being incapable of the proper control of the automobile:or

b. unless he is for the time being either authorized by law or qualified to drive or operate the automobile: or

- c. while he is under the age of sixteen years or under such other age as is prescribed by the law of the province in which he resides at the time this contract is made as being the minimum age at which a licence or permit to drive an automobile may be issued to him: or
- d. for any illicit or prohibited trade or transportation
- e. in any race or speed test.

It clearly states that in order for the insurance policy to be valid, the vehicle must be operated by a licensed and qualified operator.

The point which I would like to make is that where a parent allows an unlicensed operator to have care, custody and control of a vehicle he continued next column, ...

is violating the contract of insurance and must then assume the responsibility and liability which the insurance was originally intended.

These snow vehicles are providing a wonderful means of recreation and enjoyment, however they are capable of great speeds, put at the hands of unqualified operators result in bodily injury and death. Over the holiday weekend there were eight fatalities, many untolled injuries and damage to property.
