Mr. Beebe said "I sincerely feel that the Province is now offering us the apportionment of participation in guiding the decisions which will affect our future. Let us act now, and therein be a voice of substance and wisdom, rather than one of frustration and anguish, and fruitless appeal, after it is too late."

It is noted that Reeve Ed Cavanaugh was appointed to this committee to represent the North Shore area. The first meeting of this committee will be held on Saturday, May 3rd.

Approximately 11 other Mayors and Reeves and Representatives from Indian Band Councils, as well as representatives from unorganized territories and Improvement Districts make up the remainder of the committee.

The Northwestern Ontario Conservation Federation will hold a Weekend Seminar in Terrace Bay on April 25 - 26. Mr. Stan Hodgkiss requested Council to sponsor a coffee break, in his letter informing them of the meeting. Council agreed.

The District Children's Aid Society submitted their final budget.

The Township of Schreiber advised Council they will observe Daylight Saving Time from April 26 till October 25th.

A letter was sent to J.R. Marsh, of the Ontario Water Resources Commission about repairs to the sewage disposal line.

The Ontario Lands and Forests Department were advised that Jack Chapman has been appointed as Bush

Fire Chairman.

Council received a letter of thanks from Councillor Allen, for the note of condolence sent to him on the passing of his father.

The Fire Department stated they had their regular Fire Practice with 19 members present. There were three fires in March.

The Building Inspector reported there were no permits issued in March.

By-law 234, being a by-law to appoint a Lottery Licensing Officer in Terrace Bay, naming W.J. Hanley, was passed.

Accounts passed for payment were: Township: \$189,341.12; Hydro \$10,781.01; Library; 644.03; Recreation; 6,328.16.

Councillor Bray advised Council that due to the resignation of Cy Brassard from the Recreation Committee, another member should be named. Council instructed Mr. Bray to request a recommendation from the Recreation Committee.

The Chamber of Commerce advised Council they had contacted the Department of Lands and Forests

about caring for Aguasabon Gorge, a natural tourist attraction in Terrace Bay. Council will call a meeting between the Chamber of Commerce, Lands and Forests and the owners of the property, Kimberly-Clark, to come to some agreement on this matter.

After a two month trial period, under a new system, for the local Dog catcher, Council reviewed the situation and decided the system was not satisfactory. A resolution was passed, releasing the present dog catcher from his duties, and they will advertise for other applicants.

Councillor Allen reported on the last District Children's Aid Society Budget meeting, held in Nipigon. He stated that the revised budget presented at this meeting showed a decrease of \$22,615. over the original proposal submitted at Thunder Bay.
