

## "THE OWL'S HOOT"


FOURTH TROPHY WON BY SCHREIBER HIGH

the method which was used to impose an important decision on a
poorly-informed and unprepared staff and public (and, I might
add, Board of Trustees, since the motion and the reasons for presenting the motion came before the Trustees about 10 days before
the decision was to be made. Can anyone wonder why this aroused

He has oversimplified the problem by saying the group against amalgamation is "a well organized group of Terrace Bay citizens". He overlooks the whole problem of staff involvement. Our staff throughout the whole area is recognized to be highly competent and professional in their attitudes and action. They resent the proposal being made without any real information, or reasons for such a change, or invitation to submit their professional opinions on the matter.

Finally, the unfortunate threat that one town may benefit more than another is a disgraceful and illogical suggestion. It colors all that was of value in the earlier arguments in the letter. It suggests to me that the real reasons behind his support are political-our town against your town. The logic here eludes me: is not the whole plan of amalgamation aimed at "improving the education situation and the efficient operation" of the two schools? Then why should the writer worry over the money issue?

I am disappointed that "A Trustee" is thinking mainly in terms of financial savings. We are not even sure that the savings will be very significant at all. I am disappointed that he took the weakest arguments in opposition to the proposal; he is quite right that these do not deserve lengthy consideration. But the Grade XIII question has already been dealt with by the Board – it will remain in Schreiber for 1971-'72.

I am disappointed that he failed to sign his name.
