## "DISTRICT NEEDS" DISCUSSION TOPIC

The District of Thunder Bay Home for the Aged Board travelled to Schreiber for their meeting on Saturday, March 20th, 1971. Prior to the meeting, Board members were tendered a dinner by the Township of Schreiber.

The meeting was held in the Schreiber Municipal Offices, municipal people in the area were invited to attend. Council members from Terrace Bay, Marathon and Schreiber were present. Manitouwadge people were unable to attend due to a meeting being held in their area.


The Board Chairman, Mr. J. Symington, stated the need for additional beds for the Aged in the District and explained to those present that the Board is considering acquiring the Barker home in Geraldton for normal care residents and also adding additional bedcare beds to Pinewood Court in Thunder Bay.

Considerable discussion took place as to the needs in the district and as to whether accommodation should be concentrated in one area or smaller homes in local areas. It was quite apparent that municipal people in attendance were in favour of adding on to the existing Home; however, they questioned the Board as to the wisdom of establishing Homes inlocal areas.

The Board explained that there was a need in Geraldton and the surrounding area and felt that the Barker Home could be acquired and converted at a reasonable cost.

A regional conference will be held in Fort Frances on April 23, 1971 and Administrators, Supervisors and Board members from the five homes in the North West will hold workshops to discuss the heavy demand for bed-care beds and the changing role that Homes for the Aged will have to follow in the future. Mrs. Sideen will attend from the Pinewood Court Board with Mrs. Ferrier as an alternate. The next Board meeting will be held in Geraldton on Thursday, April 15th, and municipal people in the area will be asked to attend. The Board plans to inspect the Barker Home at the same time.
