The following resolutions were moved and carried:  
1) Resolved that: the minutes of meeting No. 8/71 be and they are hereby declared adopted. 2). Resolved that: The minutes of meeting No. 1 of the Public School Trustees be, and they hereby are declared adopted. 3). Resolved that: The minutes of meeting No. 21 of The Advisory Committee to the Trainable Retarded be, and they are hereby declared adopted. 4). Resolved that: The Board approve the expenditures for the Month of June, 1971, as listed

in the Disbursements at \$343,449.42. 5). Resolved that: Mr. Esko Autio be appointed to fill vacancy on the Board of Trustees, as occasioned by Rev. M. Beacom's resignation, to hold office for the remainder of the current term of office. 6). Resolved that: The Board approve the addition of an additional bus run from Coldwell to Marathon at noon commencing September 7, 1971, to accommodate kindergarten pupils who attend for one-half day only, at a cost of \$9.00 per day, at the discretion of the Director. 7). Resolved that: We suggest to the Onario committee for Education Week that Education Week be held in late October commencing in 1973.

Trustee B. McDonald reported on progress regarding the athletic field in Terrace Bay.  
8). Resolved that: A community centre in the form of an athletic field by established under the Community Centres Act on the property owned by The Lake Superior Board of Education in the Township of Terrace Bay, and that the Athletic Field remain at all times under the control of the Board in accordance with the regulations of the Department of Education; and that we appoint the members of our School Board to manage same.
