

## COUNCIL QUOTES

Terrace Bay Town Council met in regular session on Tuesday evening. The minutes were adopted as read.

Correspondence included a letter from J.A. Ferrier, Mill Manager, Kimberly-Clark, stating that the Central Heating Plant will be operating as usual throughout 1972 and into 1973.

The Knights of Columbus requested permission to sell tickets on a draw. Permission granted.

The Thunder Bay Health Unit advised Council of the appointment of Dr. Jane Pickersgill as the Medical Officer of Health.

The Ladies Auxiliary to Guides and Brownies requested permission to sell Licorice All Sorts on December 17th, permission granted.

A telegram from Mayor E. Carter, Mayor of Kenora, asked Reeve Cavanaugh and the Council to endorse an amendment, to be sent to Premier W. Davis, regarding studded tires in this part of Ontario in the interest of safety, Mr. Cavanaugh endorsed the recommendation.

The Department of Transportation and Communication advised of a seminar to be held in the Airlanes Motel on November 25th and Clerk W. Hanley was appointed to attend.

Terrace Bay, Schreiber, Marathon and Manitouwadge accepted the decision of the Arbitrators regarding the apportionment of the 1969-70 levies proprosed by the Lake Superior Board of Education, and the apportionment of the 1971 levy.
