INVITATION TO SUBMIT WRITTEN BRIEFS

On June 30th, 1972, the Ontario Legislature appointed a Select Committee to examine, inquire into and report upon the Ontario Municipal Board and to make recommendations on: (a) the purpose, object and functions of the Ontario Municipal Board. (b) the jurisdiction of the Ontario Municipal Board. (c) the structure and organization of the Ontario Municipal Board. (d) the procedures and practices of the Ontario Municipal Board. (e) the procedures by way of appeal from the orders and rulings of the Ontario Municipal Board, including appeals by way of petitions to the Lieutenant Governor in Council. (f) the relationship of the Ontario Municipal Board in the discharge of its responsibilities with the Provincial Government, Local government and the individual citizen. The Committee invites written briefs from individuals and organizations who may wish to present information, opinions or suggestions regarding any of the above matters relating to the Ontario Municipal Board.
