Notices of Complaint must be made in writing either by letter or on forms available at the Municipal Offices.

For purposes of identification, please include your name and postal address, and the reason (s) for complaint. If possible, note also the assessment roll number, the street address, concession and lot numbers, and the municipality in which the property under complaint is situated.
