Mr. B. McCracken has been appointed as Head of Guidance at the Lake Superior High School, effective September 1st, 1973, with salary according to schedule.

The Board approved the appointment of Mr. K. MacLeod as Principal of the Schreiber-Terrace Bay Public School, effective September 1st, 1973, with salary according to schedule.

The following appointments were approved effective September 1, 1973, with salary according to schedule: William Climie-French-Marathon High School; Ralph Burgess-Commercial Director-Lake Superior High School; Dennis Shulha-Guidance-Manitouwadge High School; Lyn Shulha-Physical Education-Manitouwadge High School; Carol Brown-Level I-Manitouwadge Public School and Dawn Offord-Level 4-Manitouwadge Public School.

Notwithstanding Resolution No. 69/71 of Board Meeting No. 6/71 dated May 1, 1971, the position of vice-principal in the Marathon High School will be abolished, effective the end of the present school year.

An advertisement will be placed for a Maintenance Co-ordinator for Terrace Bay and Schreiber at a salary of \$3,000.00 per year, which covers all travel.

By-Law No. 20, being a by-law to borrow money, by the issue and sale to the Ontario Capital Aid Corporation of a debenture in the principal amount of \$227,000.00 bearing interest of 7½% per annum payable semi-annually to be repaid in 20 annual installments, for the Terrace Bay Public School Capital project, was read a first, second and third time and approved.

The amount of \$1,902,595.00, which includes the amount of \$661,506.00 to be raised through local taxation was set for the Secondary Revenue and Expenditure Budget for the calendar year 1973.

The Board approved the Elementary Revenue and Expenditure Budget for the calendar year 1973 in the amount of \$1,300,641.00, which includes the amount of \$555,659.00 to be raised through local taxation.

The local levy in each case is break-even requirement only and does not reflect adjustments for previous years.

A report, with estimates of repair costs, prepared by G.M. & H.O. Holmes Limited on the condition of the Marathon High School roof was presented. The Maintenance Committee will
