Hacquoil Construction submitted a quotation for surface treatment as Council had requested. The decision was made by those present to have the sides of the streets completely swept free of stones as there is a good surface layer under this.

Council has proclaimed June 25th - July Ist as Canada Week in Terrace Bay.

Building permits were approved by Council due to the Building Inspector being out of town.

A letter from Gilbert Plains requested the purchase of Maurice Dozois' police uniform and other items for the amount of \$75.00. Council agreed to this.

A letter was received from a concerned citizen regarding the method of handling juvenile offenders by the Police Department. This citizen felt giving the youths work to do instead of jail sentences or the like would be far more beneficial.

A letter received regarding a flooding problem on Superior Ave. will be looked into by Councillor Hale.

Under new business Councillor Helmink asked Council for the sum of \$800.00 to be given to the Canada Day Committee with the amount of \$300.00 guaranteed.

Council also granted permission for property in front of the municipal office to be used for a beer garden on Canada Day. The municipal office washroom facilities will also be available providing they are attended.

A discussion was held regarding the cost of gas alone being more than the tender submitted for rental of a ½ ton truck. Councillor Hale felt strongly that the township should purchase their own vehicle. This matter will be discussed further when a full council is in attendance.

The matter of the condition of the Moose Hall and the Railway Station Roads will be looked into.

A letter will be sent to local businesses reminding them of the changes in garbage pickup and the use of the land fill site.

The matter of grants available for renovation to the recreation center heating system will be looked into.

Councillor Helmink is still trying to narrow ow down the cost of operating the Curling Club and Councillor Hale volunteered to try and obtain some of this information.
