Township accounts of \$23,864.79, Hydro \$17,988.55, Recreation Committee \$9,038.72 and Library \$930.75 were passed for payment.

The Township budget of 694,279.00 was passed for 1973.


Residential separate school mill rates are down 3.27I and public school is down 2.708.

Commercial Separate School mill rates are down 2.987 and Public School 2.36I.

Mill rates adopted for this year are -Public School 28.I76 as compared to 30.884 in 1972 and Separate School 27.I93 as compared to 30.464 in 1972.

Four flags will be placed in Centennial Park for Canada Day and two will remain up after the events have been held.

The Council of the Town of Oakville at a recent meeting passed a motion urging all Municipalities in Ontario to request the Province of Ontario to amend the Dog Tax and Live Stock and Poultry Protection Act to allow a ticket system for dogs-at-large offences, such as presently applies to parking offences. The philosophy of this proposal is that a simplified procedure would encourage better enforcement, and the owner would be penalized by being given a ticket and summonsed on his fail-

ure to pay rather than the dog being impounded. Terrace Bay Council endorsed this motion.

A letter containing the following changes in the functional use of the Recreation Centre was sent to Mr. G.L. Puttock, Kimberly-Clark of Canada Ltd. -

- "(a) relocation of the present games room to the area known as the Arts and Crafts Room; this room would be re-named "Youth Drop-in Centre". Physical changes would involve removal of existing temporary wall and draft wall. Installation of electrical strip to accommodate pinball machines.
- (b) relocate employees lunch room and storage shelves from Art and Craft Room to the small meeting room.
- (c) instal 3 ft. divider in lounge area to give privacy to proposed dining area (approximately five tables) and, provide a defined entrance to the Recreation Office. Physical change would be the removal of existing benches located around the window area.
- (d) the present games room would be used as a second meeting room.
- (e) Trades Training sessions would be relocated in the large meeting room.

All costs connected with the above mentioned changes will be borne by the municipality."

Council has requested consideration and approval of this.
