The topic of garbage brought about a discussion on the by-law stating that metal containers must be used and offenders will be advised of this.

The minutes of the Pinewood Court Home for the Aged Board were read.

Clerk Hanley wrote to Mr. G.L. Puttock, Kimberly-Clark of Canada Limited regarding making the Golf Course Road public stating that "Council is prepared to accept the road as a Public road and assume responsibility for future maintenance and policing providing, the road is set-out and final graded to existing standards established by the Ministry of Transportation and Communications prior to acceptance by the municipality."

Mr. Hanley also wrote Mr. Puttock requesting a meeting with Council to discuss the Development of I6 service lots - Lakeview Drive - Phase IV.

An estimate was received from Lakehead Roofing and Sheet Metal Company Limited for roof repairs to the Municipal Office. Quotations will be requested from other companies before Council continues with this matter. Kimberly-Clark of Canada Limited wrote giv -ing Council the authority to carry out the changes in the functional use of the Recreation Centre as outlined in a letter of May 3Ist, with the expense of all changes being born by the Municipality.

The June 7th and 21st minutes of the Recreation Committee meetings were approved.

Under new business the lease on garage #20 was renewed.

The By-Law regarding this years mill rates was read a first, second and third time and passed.

Councillor Brassard read a letter from Police Chief Barnett stating that Mr. George Aulenback will commence duty on July 3rd as a 5th class constable at base rate.
