which will likely be proclaimed in force effective August I, 1973. The effect of the Bill is to consolidate the existing three pieces of legislation and transfer the responsibility for inspections of construction to the Province. Section 32 repeals the existing Construction Safety Act and Trench Excavators' Protection Act, and consequently all appointments made under these Acts by municipal councils will no longer be in effect.

Certificates of approval for the construction of a sanitary sewer and a water main on Lakeview Drive were received.

On a request from the Horticultural Society for a donation to their Annual Flower and Vegetable Show Councillor Hale volunteered to purchase this prize with a maximum value set.

With Council replying to Mr. C.E. Paget on his request for daily garbage pick up at the Norwood Motel another letter will be sent informing Mr. Paget of the availability of a key to the land fill site if desired. Another request was also received from the McCausland Hospital Administrator for increased garbage pick up at the hospital. Council will advise the administrator along with the Home for the Aged that a key is available for their use providing certain regulations are followed. If Council finds any of these regulations being abused the holders of keys will have to be licensed.

Pinewood Court wrote advising Council that Barnett-McQueen will be managing the installation of heating lines to the McCausland Hospital and the Recreation complex. A letter of authority will be sent to Barnett-McQueen covering this work on municipal property.

A letter from H. Sturgeon telling of his definite interest to purchase House 73, Hudson Drive was received. Council will look into this matter from the legal aspect as to whether they can sell without tendering.

After a recent inspection of the road to Lake Superior by the Ministry of Transportation and Communications they found it would conform to the required standards for rural roads. Prior to the Township accepting this road into their system, the present owner would be required to dedicate to the Township, a right-of—way 66 feet wide minimum.

A letter from Thunder Bay Hydro notifying Council of their decision to cease participation as co-sponsor of the T.V. Program "Reach for the Top" caused the Terrace Bay Council to be doubtful of its own participation in this program in the Fall.

With the increase in compensation by the Workmen's Compensation Board for volunteer firemen, Council will revise the amount of coverage presently in effect for their volunteer firemen.
