## MINISTRY OF HEALTH APPROVES HOSPITAL BY-LAW AMENDMENT


The McCausland Hospital Board of Governors has received approval from the Ministry of Health for the recent Amendment to the Administrative By-Laws. This amendment was approved on October 9, 1973 in accordance with subsection I of Section 9 of The Public Hospital Act of Ontario and must now be confirmed at the Annual Meeting.

The effect of this amendment is to eliminate Section 3, Paragraph 3 which stated:

"No person may be elected or appointed a Governor after reaching the age of seventy (70) years."

The initial suggestion for this change to the By-Laws was made by a letter from Lester McCuaig, President of CHIMO, to the Board of Governors. The hospital wishes to thank this organization for their interest and the iniative shown by their recommendation to improve the present By-Laws.
