NOTICE

Under the Forest Fires Prevention Act,

The period from April 1 to October 31 in each year shall be a fire season.

Fire permits are required in a fire district

- for all outdoor burning except cooking or obtaining warmth

- to ignite fireworks within 1000 feet of a forest or woodland.

A work permit is required to conduct any operation which is liable to cause an accumulation of slash or debris within 1000 feet of a forest or woodland.

No person shall smoke while walking or working in a forest or woodland.

Fire permits may be obtained from local Ministry offices or township fire wardens.
