

WOULD YOU LIKE TO SERVE ON THE HOSPITAL BOARD?

Apparently there are many misconceptions concerning The McCausland Hospital Corporation, The Board of Governors of the McCausland Hospital and The Auxiliary to the McCausland Hospital which we would like to clarify. The McCausland Hospital is a public institution whose legal name is The McCausland Hospital Corporation. Any person who pays the annual fee of one dollar becomes a member of the corporation for that year and if the membership is purchased thirty days prior to the Annual meeting, may vote at the meeting and be eligible for election to the Board of Governors of The McCausland Hospital.

The Board of Governors manage the affairs of the Corporation and consists of eight elected and four ex-officio governors. If a vacancy occurs among the elected governors, the vacancy may be filled for the remainder of the term of office by an appointment made by the governors still in office.

The Auxiliary to the McCausland Hospital is an organization working solely for the benefit and welfare of the hospital through fund raising and volunteer service to the patients.

Recently two members of The McCausland Hospital Board, Mrs. Pat Buck and Mr. Barry Stephen resigned for personal reasons. The Board requires two people to fill these vacancies, one for the remainder of Mr. Stephen's term which ends in April 1975 and one for Mrs. Buck's term ending in April 1976.
