and without the need for a further application, the Ministry will return to the customer the portion of Retail Sales Tax he paid with respect to the subsidy when he bought the car from the dealer.

Mr. Meen pointed out that "in preparing reg -ulations to effect this change, my staff will ensure that these adjustments will include pur -cahse agreements made by customers from the beginning of the various programs back in mid-January.
