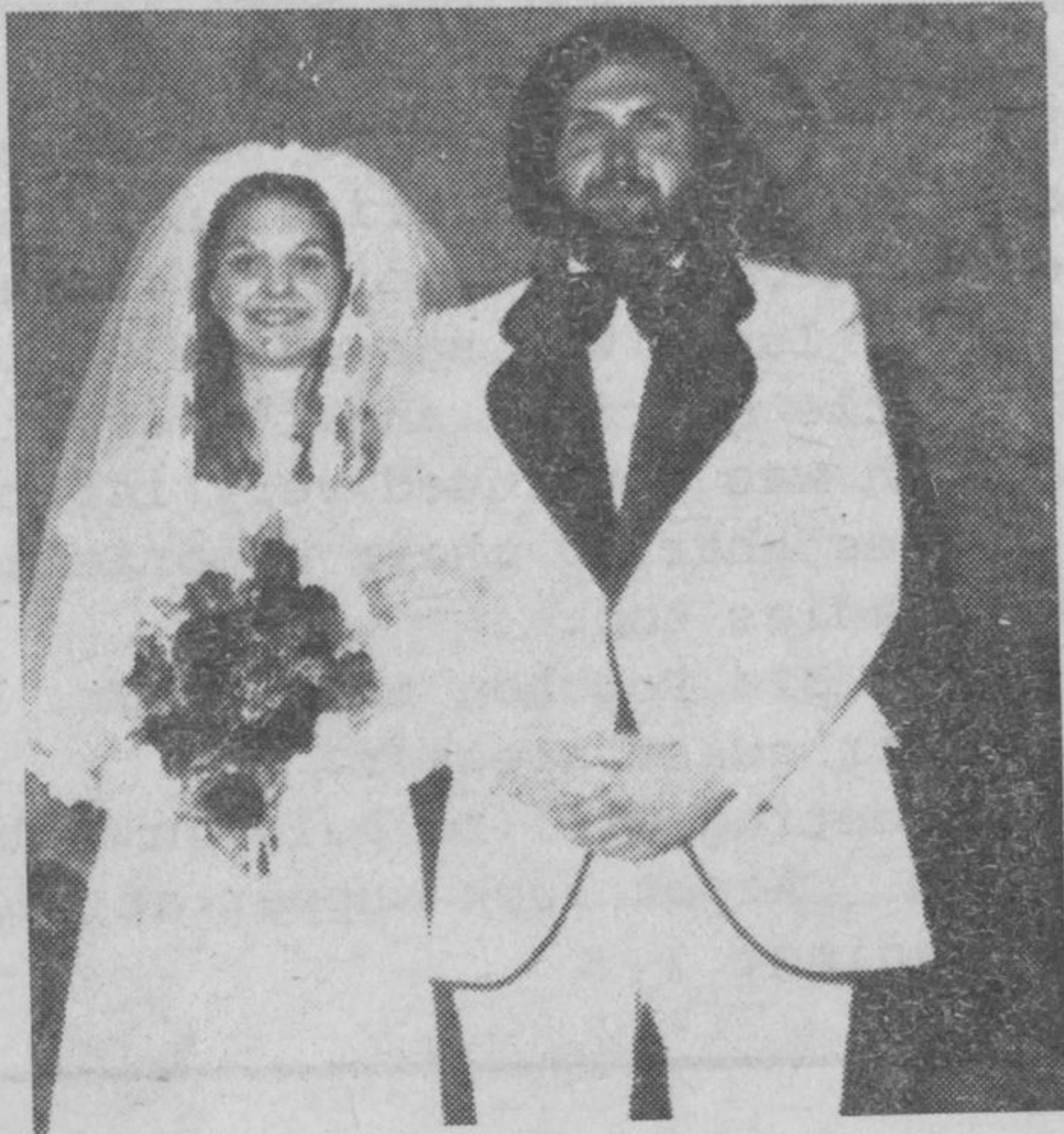


SITKO-THORPE VOWS EXCHANGED
