The minutes of Meeting No. 8/75 and Meeting
No. 9/75 were declared adopted at the August
7th meeting of the Lake Superior Board of Education.

The minutes of Meeting No. 41 of the Trainable Retarded Children's Advisory Committee were acknowledged as received.

The Disbursements for the month of June, 1975, totalled \$469,217.74 and the total for the month of July, 1975 was \$525,169.36.

The Transportation Agreement for the school year 1975-76 with North Shore Transit, in the amount of \$75,938.30 was approved.

The Transportation Agreement for the school year 1975-76, with Mr. Donat Cyr, totalled \$3,300.00 and was approved.

The Five Year Capital Forecast Committee comprises L. Murphy, D. Talarico and J. Nugent. A forecast will be prepared and presented at the September meeting for Board consideration.

R.R. Steele, Regional Director of Education, will be invited to view the present Industrial Arts facilities at Manitouwadge High School and to discuss at the September meeting a possible expansion.

Correspondence received from W. Tessier, Manitouwadge, and J. Vandergraaf, Terrace Bay, indicated an interest in purchasing their residences.

A letter of appreciation for tuition assistance was received from Miss L. Maehans, Marathon.
