

## TERRACE BAY POLICE DEPARTMENT REPORT

During the week September 29th to October 5th members of the Terrace Bay Police Department investigated a total of 27 occurrences.

September 30th - A Break, Enter and Theft was reported at a local residence where a number of fire arms were stolen.

October 2nd - damage to the value of \$600. was caused to the windows of Cebrario's Hardware. A local man has been charged with this offence.

October 3rd - As a result of an accident on Highway I7 a local man was charged with careless driving.

October 4th - damage was caused by a motor vehicle to the lawns at the Recreation Centre, Birchwood Terrace and the Golf Course.

Seven motor vehicles were safety checked and four warnings issued. Three charges were laid under the Highway Traffic Act and two charges under the Liquor Control Act.

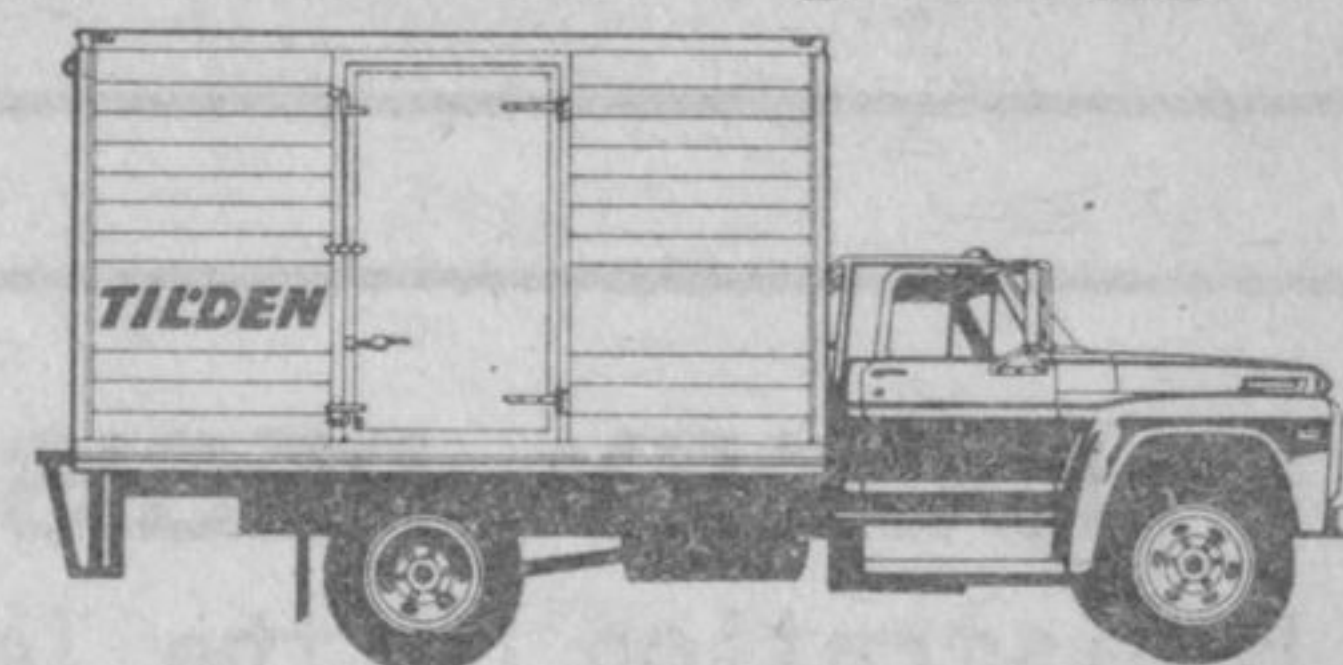
