TOWNSHIP OF SCHREIBER COUNCIL QUOTES

Approval has been received from the Ministry of the Environment to lay water and sanitary sewer lines on Peary, Ethel and Langworthy streets. It is the councils intention to proceed with cost estimates for the Peary & Langworthy St. lines, abutting property owners will be informed, and if objections are filed, it will then be necessary to have the Ontario Municipal Board conduct a hearing.

The Ministry of the Environment has also informed Council that the gargabe collection contractors, for both Schreiber and Terrace Bay are not living up to Environment standards at the Sanitary Landfill Site. Council will take immediate action to correct the situation.

By-Law 584, which rescinds By-Law 329 and 546, and prohibits the keeping of certain an-imals and fowl in the Township as passed.

Supplementary budget to the Ministry of Transportation and Communications was set at \$223,560 and covers roads, paving, drainage and sumps. This is subject to MTC approval.

A resolution was passed to request a soil and paving survey test from the Ministry of Transportation and Communications.

Council wishes to proceed with the formation of a cemetery board, and will investigate the possibility of building a vault at the cemetery.

General accounts to the amount of \$9,372.88 were passed for payment.

Council has requested quotations from three engineering firms to make a structural and safety inspection of the Citizens Rink, as required by the Ministry of Labour. The selection of a firm is under consideration.

The lease of land from Marathon Realty for the Fire Hall was renewed at \$100.00 per year.

LOW COST CONSULTING

AVAILABLE TO BUSINESS

Low cost management consulting services for small businesses is being made available this

year through the Small Business Assistance
Program (SBAP) of the Ontario Ministry of Industry and Tourism.

For the fourth year the Ministry will undertake the program, with 120 university business administration students supplying counselling services to small businesses from May through August.

Counselling by the graduate students covers such areas as cash management and financial planning, bookkeeping systems, production scheduling and cost control, marketing and marketing research, distribution and promotion.

Claude Bennett, Ontario Minister of Industry and Tourism, said the SBA Program offers business counselling at a very low cost in areas essential for the success of small promotion.

"Last year" he said, "700 consulting assignments were completed for 568 companies.

These companies had, in total, sales in excess of \$80 million. Although the typical company that received assistance was small, the combined contribution to Ontario's economy is significant."

Business administration faculties of 12 Ontario universities - Carleton. Lakehead, Laurentian, McMaster, Ottawa, Queen's, Ryerson, Toronto, Western, Windsor, Wilfred Laurier and York - will be participating in the program.

Students work is closely supervised by university faculty and is supported by services
available from Ontario Ministry of Industry
and Tourism specialists in technology, marketing and service industries.

As it is not intended this service compete with private consulting firms, businesses eligible for the service must not be in a position to engage professional consultants.

Cost of the service borne by the Ministry, although a nominal fee is charged to the businesses using it.
