Dear Mr. Mathew

"When I met with you and members of your Board on May 28th, I agreed to consider the possibility of providing 5/6th capital funding for the doctors' offices and related facilities which you are proposing to include within the new hospital which is presently being planned.


Following our meeting I have had an opportunity to discuss this matter with Dr. Baldwin. His concern, like mine, is to ensure an effective integration of health care services in your community. That is a desirable objective which we all support. It was for that reason that this was included in your functional program. However, as I explained to you at our meeting, it is not usual for us to provide capital financial assistance for such facilities in community hospitals.

In view of the strong concern which was expressed at our meeting, I have reconsidered this matter and have had the opportunity of a discussion with Dr. Baldwin to determine his views on the matter. Following this review of the position I must reconfirm that it will not be possible for us to provide 5/6th capital financial assistance for the "doctors' office" accommodation which you are proposing to include in your hospital. Capital funds are in extremely short supply and I see no opportunity to make additional capital funds available for this purpose. Accordingly, therefore, while we do support the concept we are unable to provide capital financial assistance.

As I explained at our meeting, the normal method of proceeding in these circumstances would be for the hospital to meet the full cost, to have this recognized as an auxiliary operation, and to recover its cost (or such portion as it deems appropriate) from the rental charged to the physicians in your community.


While I appreciate and respect, the depth of feeling your Board has on this matter, I hope you, equally, will appreciate that it would not be consistent with our policy to support the costs of this accommodation.
