visual difficulties and is not already under treatment by an eye specialist. An appointment for an eye examination can be made by calling 825-3840.

This Prevention of Blindness Program is sponsored in Terrace Bay by Kinsmen Club and is operated by the CNIB, Prevention of Blindness and Eye Service Department with the assistance of the Section on Ophthalmology OMA. Trained CNIB personnel, including an ophthalmic assistant, manage the daily program.

INFORMATION ONTARIO PART II

This is Part 2 of a 4 part series on Information Ontario news releases concerning the Ministry of Revenue.

I again remind you, if you have a specific problem that you are encountering, you should then contact your solicitor or the Ministry of Revenue, whose address you may obtain through the Northern Affairs Office.

4. Is there a federal tax in addition to this provincial tax?

ANSWER: You are probably thinking of the federal withholding tax with respect to The Income Tax Act. Reference should be made to the Department of National Revenue for answers on questions of this nature.

5. Are there any other provincial restrictions on Americans owning Canadian real estate

A) As to the size of the lot?

B) As to the total acreage?

C) As to the number of properties?

ANSWER: We would not be qualified to reply to this question regarding other provincial restrictions as to the size, lot or total acreage or the number of properties that may be purchased by any non-resident.

6. If an American sells to a family relation does the tax still apply and who is considered family?

ANSWER: The question here would be as in 3.A. yes the tax does apply on the value of consideration for the conveyance.

7. If the same person gives this property to a member of his family does the tax apply?

ANSWER: If the property is given as a gift for natural love and affection, there would be no value of consideration and land transfer tax may not be applicable but it may very well fall within the provisions of The Gift Tax Act.
