TERRACE BAY POLICE DEPARTMENT REPORT

During the week of October 10th to 17th Police investigated 34 occurrences within the Township.

During the week three charges under the Highway Traffic Act and five charges under the Liquor License Act, were laid.

On Monday, October 11 Police acted as intermediary for a dispute between two construction workers, the result that both parties returned to camp.

Later the same day a constable on patrol discovered a break and enter at the fire hall. Early on October 12 a break and enter was reported at the Red Dog Inn. Police investigation into these two offences has resulted in three Terrace Bay men being charged. Early in the evening of October 12, 1976 a routine spot check resulted in charges of Possession of Narcotics being laid against a Sault Ste Marie resident.
