The present policy of the Ministry of Community and Social Services is to find ways and means to assist Seniors in their own communities and, he is looking for ideas from anyone working with Seniors.

Presently, there is pressure on Pinewood Court which will possibly force an addition to this Home prior to proceeding with small residential care Homes in Nipigon and Geraldton.
