

TERRACE BAY POLICE DEPARTMENT REPORT

During the week of November 7th to 14th a total of thirty-eight occurrences were investigated by the Terrace Bay Police.

On November 7th Police attended two disturbances at a local business establishment which resulted in parties leaving to return to the Construction camp.

On November 8th Police investigated one Fail to remain at the scene of an accident, issued two parking tickets, one charge of speeding and one charge of failing to stop at a stop sign were laid.
