POLICE REPORT - 21 - 26 JUNE 1977:

The Terrace Bay Police Force reports a fairly quiet week for the period 21 to 26 June, as only seventeen occurrences were logged.

A male person from Newfoundland skipped with-out paying for his lodgings at a local motel. This matter is presently being investigated.

Police were called upon to investigate a vehicle accident on June 23rd at the intersection of Hudson Drive and Selkirk Avenue.
