WOMEN MAY USE MAIDEN NAME ON DRIVER'S LICENCE

Ministry of Transportation and Communications James Snow announced that Ontario women drivers now have the option of using their maiden name or a former husband's name on their driver's licence.

"If a woman wants to change the name on her driver's licence," said Snow, "she can go to any Ontario driver examination office, present the proper documents for identification, and fill out a name change application form."

"On completion of the application, a temporary driver's licence will be issued in her changed name at no extra charge."

The permanent driver's licence will be mailed to the applicant at a later date.
