
## REMEMBRANCE DAY ACTIVITIES IN TERRACE BAY

Resolution No. 41/77 authorized Principals, in consultation with the Director of Education to hire additional teachers required at the beginning of a school year as a result of unforeseen increased enrolment. This motion was rescinded with the understanding that should such an emergency staffing situation arise prior to a regularly scheduled Board Meeting, Trustees would be contacted with a view to filling the staffing requirements as quickly as possible.

It was resolved that all course offerings be tentatively approved at the local level by Trustees and Principals, annually, prior to the distribution of option sheets; formal Board approval to be obtained by April 30th.

The Board approved the Lake Superior Public School Grade 8 Major Excursion to Toronto from May 29th to June 3rd, 1978.

The Board approved the submission of an application for renewal of the 1977 Community School Development Project, Proposal "Participaction and Coordination," in the amount of \$6,000.00, subject to Ministry approval.
