SNOW REMOVAL: .

Section 116(10) of the Highway Traffic Act of Ontario provides that - Notwithstanding the other provisions of this section, no person shall park or stand a vehicle on a highway in such a manner as to interfere with the movement of traffic or the clearing of snow from the highway.

Every person who contravenes any of the provisions of this section is guilty of an offence and on summary conviction is liable to a fine of not less than \$5 and not more than \$50.

Motorists are requested to co-operate and ensure that their vehicle does not hinder the clearing of snow from our streets.
