- Q. I understand that I may be eligible to claim two federal tax reductions this year. Please explain.
- A. Everyone is eligible for the general tax reduction. The minimum general tax reduction you are eligible to claim is either the amount of your basic federal tax or \$200, whichever is less.

 Beginning this year there is a tax reduction for children. Basically, you can claim an additional tax reduction of \$50 for each dependent child living in Canada and under 18 years of age on December 31, 1977. (The number of children that you claim should be shown on line 63 on page 4 of your return.)

 The maximum amount you can deduct for the two federal tax reductions is the least of:
 - (a) the total of your general tax reduction and your tax reduction for children
 - (b) your basic federal tax

OR

OR

(c) \$500.
