

THE DR. MCCAUSLAND-BURSARY-SCHOLARSHIP AWARD

1. ELIGIBILITY OF STUDENTS

- (1) Students must be residents of Terrace Bay, Schreiber or Rosspport, Ontario and registered in full time attendance in Grade 12 or 13 in any accredited High School in Ontario, during the school year in which award is granted, or have attended full time during the previous school year if already in attendance at an institution of higher learning.
- (2) Awards shall be restricted to deserving students of good character who continue their formal education in an institution of higher learning.

2. VALUE OF AWARD

The value of the award is based on the interest earned on the Principal invested and this should normally produce three hundred dollars per year.

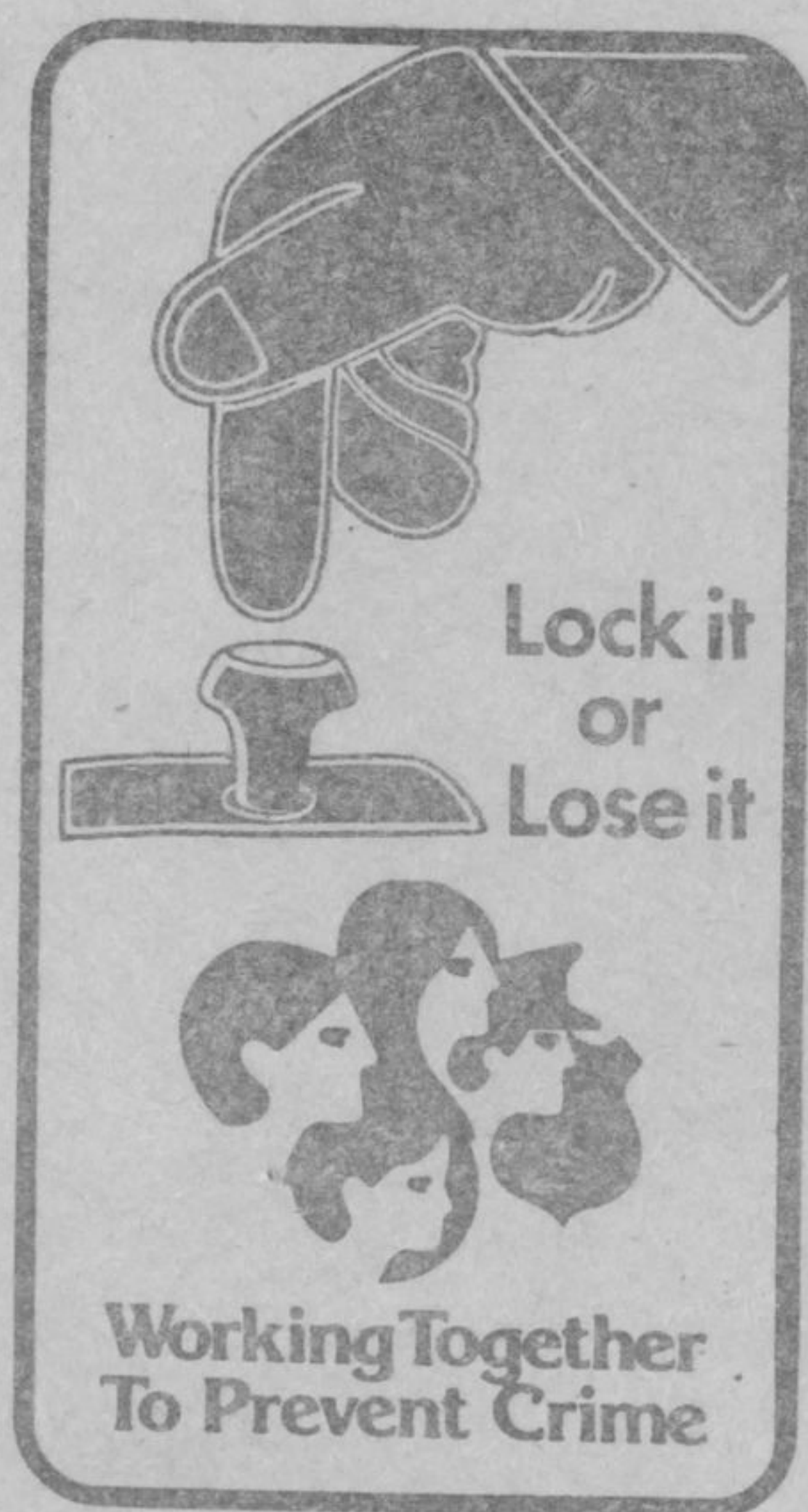
3. PAYMENT OF AWARD

(1) The Dr. McCausland Bursary-Scholarship Award shall be paid during the fall term after the receipt of certification, by the head or registering official of an eligible institution, that the student is enrolled.

(2) Should a student selected for an award fail to enroll in an institution of higher learning under the conditions outlined above, then the award shall be forfeited. The award will be made available to another eligible student at the discretion of the Trustees.

(3) If there are no eligible students for the award in any school year, then the Trustees may consider granting the award to former students of Terrace Bay, Schreiber and Rosspport who are already in attendance at an institute of higher learning, and are in need of financial aid to continue their education.

Application for the award should be sent to Mr. J. Ferguson, Terrace Bay and shall contain the marks for the subjects taken in the last 3 (three) semesters or equivalent. The institution and area of study proposed by the applicant must also be indicated and the deadline for applying for the bursary is June 2, 1978.
