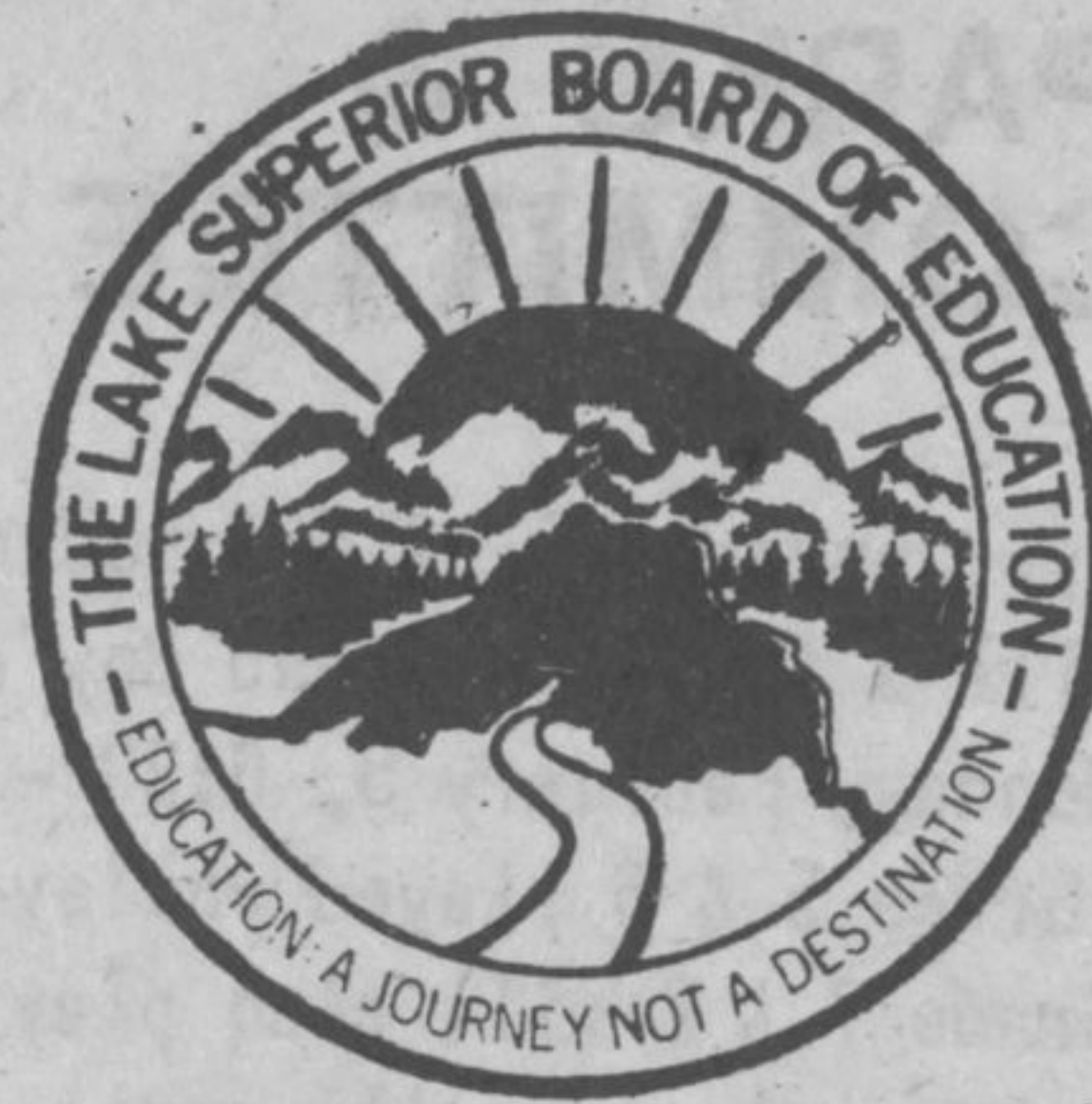
TAKE NOTICE THAT the Court has fixed the 23rd day of February 1979, at 2:00 o'clock in the afternoon at the Registrar's Chambers, Room 232, 145 Queen Street West, Toronto, Ontario, to the application of Antonio Candeloro, bankrupt, for the discharge and take notice that if you intend to oppose the bankrupt's discharge, Section 140(7) of The Bankruptcy Act R.S.C. 1970, C.B-3 requires that you give notice of the intended opposition, settling out the grounds thereof to the Trustee and the Bankrupt.

The notice should be in writing and a copy thereof filed with the Court on or before the date set for hearing, otherwise the application may be dealt with by the Registrar on that date as unopposed.

AND TAKE FURTHER NOTICE THAT if you oppose the application by giving written notice to the bankrupt and the trustee and by filling a copy with the Court prior to the date set for hearing, you need not attend on that date before the Registrar. The application will be adjourned to a date before the presiding Judge in Bankruptcy, and you will be notified of the time and place by mail by the Registrar's Office. You should attend in person or by Counsel on the adjourned date before the Judge.
