Jackfish meet stiff opposition in Marail. In

Residents of Jackfish and Marathon squared off in a sometimes heated debate on Monday of last week.

The Lake Superior Board of Education has been under intensive lobbying from Jackfish residents to extend the Board's boundaries to take in the rural and wilderness areas not now in the Board's jurisdiction lying between the four major communities of Marathon, Manitouwadge, Schreiber and Terrace Bay.

The former school board passed a motion sponsored by Terrace

Bay Trustee Joan Nugent which annexed the areas subject to final approval from the Ministry of Education. Following the November elections several Board members raised questions about the adequacy of the resolution and whether or not enough thought and planning had gone into the Motion before it was passed. Terrace Bay Trustee Jim Figliomeni led a move that resulted in the tabling of the annexation until the details could be worked out. Supportees of the tabling motion said after the

meeting that they thought the original Motion was "premature and carelessly word-

The Ministry of Education subsequently advised the Board that it would not be able to proceed with the previous Board's annexation motion whether it had been tabled or not because the motion mentioned only vague geographic areas, failed to define specific boundaries and lacked the necessary supporting documentation on the students resident in the areas.

The Board of Edu-

cation decided to set up a Committee to study the entire matter. The Committee consisted of four Trustees, two property owners paying taxes and two property owners not paying education taxes. The Committee members were to talk to the people in their communities and determine their opinions, hold a public meeting in Marathon on February 14 to listen to anything that anyone wanted to say about the question, and then make a Recommendation to the Board at its February 21 meeting on whether to annex or not, and if so, what to annex.

About 65 people attended Monday night's Public Meeting with about 50 of them Manitouwadge and Marathon residents strongly op. posed to annexation.

Mike Reid chaired the meeting and sketched the background for the audience. Reid then said, "We are here to listen to what you have to say. The Board has not made up its mind about this, but when we do it will be based largely on what you have to say here tonight."

The Board Committee

consists of Chairman Mike Reid, Terrace Bay Trustee Gerry Armour, Schreiber Trustee Tim Delaney, Marathon Trustee Bob Cheetam, Jackfish resident Mrs. Charlotte Kneipp, Gerry Waghorn from Marathon, Rob Gallen from Manitouwadge, and Bill Keating of Schreiber.

Terrace Bay Trustee Gerry Armour acted as spokesman for the Jackfish residents and used several maps to show the areas he felt it would be appropriate to include in the enlarged Board.

Marathon's Gerry

Waghorn lead a vigorous defence Marathon cottagers case against annexation. The Committee itself appeared strongly split with the Jackfish and Marathon members holding to their original positions throughout the evening.

After the Meeting several members of the Committee suggested that there would probably be both majority and minority Committee Reports going to the Board at its meeting on Monday, February 21 in Marathon.
